The National Commission on Indigenous Peoples-Regional Office III, through the **FY 2016 GAA** intends to apply the sum of **Seven Hundred Ninety Nine Thousand Pesos (P799,000.00) only** being the Approved Budget for the Contract (ABC) to payments under the contract for 2016 MITHI ICT REFRESH Project.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The NCIP-Regional Office III now invites bids for the procurement of computer hardware for use of its various provincial offices. Delivery of the Goods is required within a period of **seven (7) calendar days**. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

4. Interested bidders may obtain further information from the NCIP-Regional Office III and inspect the Bidding Documents at the address given below from **27 May – 16 June 2016 @ 9:00 AM-5:00 PM**. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee in the amount stated above.

5. Pre-Bid Conference will be on **6 June 2016, 9:30AM** at the NCIP Regional Office conference room which shall be open to all interested parties. Bid opening shall be on **17 June 2016, 9:30 AM** at the NCIP regional office conference room. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

6. The NCIP-Regional Office III reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
